3- The textual coherence in Sur: (news, disputes,

This research revolves around the characteristics of scriptural coherence in the Qur'an through a wall (for news, contention, abomination, and concoction) and the rules and means of this cohesion, as a representative of a unique linguistic style of the Holy Qur'an.

I chose these walls to be a chosen model; to reveal the characteristics of the textual coherence in them, and their rules, and their compatibility with the rules of textual consistency in the Arabic language in general, and all these walls are characterized by the following:

First, it is a wall of Makiya, and the Makki wall has stylistic characteristics that are not found in the civil wall, most notably the Palace of the Wall and the Palace of Verses, the speed of the rhythm and the homogeneity and harmony between the verses and their verses.

this point, but the Quranic passage plays a great role in the cohesion, rhythm,

In dealing with the characteristics of the connection, in this wall, I relied on the analytical descriptive data which is based on monitoring the phenomenon and analyzing it and clarifying the rules and textual mechanisms that I have monitored based on the textual data. I have made statistics about the prevalence or scarcity of some textual phenomena on the one hand and the extent to which they agree with the textual rules governing the Arabic language in general.

There is no doubt that the study of textual links goes beyond the level of syntax to the construction of a text based on the whole sequence in a linguistic and semantic context, which makes it an authoritative text.
