ABSTRACT

Praise is to Allah , Lord of the Worlds, peace and his prayers are on the creatures' Mr., the honored and supervised of messengers, Prophet Mohammed and his family, companions, and after.

This research was meant to highlight the role of a Muslim scholars in the field of religions comparative , namely Sheikh "Jawad Sabat bin Ibrahim Sabat Al-Hasani Al-Hanafi " (1250), through the study and verification his book of "Albraheen Al sabatiyah" by including a number of spiky issues that a lot of argument and discussion were around it between Christians and Muslims since rise of Islam sun, and these issues: distortion the Bible, The Trinity and the union, consider the Christ as God and his prophecies and Evidence prophecy of Mohammed from the Bible.

This scholar write his previous book at time when increased movements preaching and Christianization between Muslims in the Islamic countries in general and the Indian subcontinent in particular; because of falling under the control of the English occupation, which has resulted in turning many Muslims into Christians, So our author composed category of the book to show the Muslim for that beliefs which Christians adheres to are incorrect , it is contrary to the teaching of the Christ , and then in this book- The Bible also included talk about the "Mohammed " to truthfulness confirms his prophecy and he is the last prophet and so we should trust him, and faith of his letter and his invitation, and who contradicts; Losing strayed right path.

This research includes an introduction, two parts and a conclusion.

Introduction indicates the importance of this book, and the optional reason for his study and his investigation, and The difficulties which faced me at that, and methodological issues in the study of this book.

The first section (the study), contains two chapters:

I - entitled (Alsabati: his time, and translation, his method and his source), and contains four Investigation:

The first topic (Alsabati age), has been appropriated to talk about the political, religious, social and cultural rights in India in the age of the author, and I referred to the effect of each of them in the formation of cultural and thought, and the role of author in those events.

The second topic (Alsabati translation), which talked about the birth of author and his origin and his trip to India, and their impact on visibility, and ageing, and his Authors, and His juristic belief and contractual, and ends by mentioning his death.

The third topic (Alsabati method in the study Christians), Discovered about the methods which the author follows in cash Christianity, and refutation of their beliefs, and the most important of these approaches: curriculum descriptive, analytical method, the comparative method, and other approaches that I have to in this subsection.

The forth topic (Alsabati sources in the study of Christians), and view sources from which it adopted Alsabati, and obtained their ideas and information, these sources have varied between Muslim and Christian, it is the most important Islamic sources: The Holy Qur'an and Hadith Sharif, and the most important Christians sources: The Bible and The Book Of Common prayer . Then talks about the sources of Alsabati reported, and Step about him, the most important: the book "Izhar Al-Haqq" to Sheikh "Rahmat ullah Al-Hendi".

Chapter II came entitled (to study the issues of the manuscript), and includes four Investigations:

The first topic (study of Bible) reports the author evidence distort Christians in The Bible, the author has adopted two kinds of evidence in proof of corruption: **first** - evidence from the Qur'an , **second** - evidence from the Bible, and then supported the statements with words Author The previous rounds of the opinion that increase strength.

The second topic (Faith Laws and doctrines Protestants),

addressed the criticism of the main faiths Alsabati included in the law of faith and Protestant faiths, including: providing faith understanding, Triangulation, incarnation, and the original sin (inherit guilt)."Adam"

The third topic (Heroes Deism Christ, and prove his prophecy), came in three demands:

1. **First requirement** (Heroes Deism Christ), said the most important evidence by Christians on parenthood, and how refuted Alsabati and alert, and strengthened his opinions with previous statements and subsequent them.
2. **Second requirement** (prove prophecy of Christ), which provided evidence on the basis requirement to proof his prophecy, and explained its relevance and of which Alsabati to prove prophecy
3. **Third requirement** (suspicions of the Jews about prophecy), the includes the suspicions protested Jews denied prophecy of Christ (Alsabati it, and prove false and corruption. The most marked this requirement stated in the authenticity innovation and lead.

The forth topic (proofs of Mohammed's prophecy), and includes two requirements:

1. **First requirement** (Suspicions of the Jews and Christians around his prophecy), and reported that suspicions raised by the Christians around Mohammed's prophecy), Alsabati refute them, (indicated through a presentation of Alsabati to suspicions that preceded the most forward " Al-Imam Nagm Al-Dine Al-Tofy " in his book "The Islamic triumphs", and I indicated that the addition of "Alsabati" from the views and statements.
2. **Second requirement** (prove Mohammed's prophecy in The Bible) shows evidence which Alsabati Inferred in that the Bible

had talks about "Mohammed" (comparing evidences what Alsabati mentioned and previous mentioned, and stressed that more evidence characterized the authenticity and the accuracy in the discussion, and subsequent have been affected by his discussion in most of this evidence.

Section II (verification), it includes the following:

First - (method of verification), which has stated:
