Despite the efforts of the Ministry of Education to raise the level of the educational process, the process of educational Supervision has not developed qualitatively in line with the development of the world, it has remained the practice of some supervisors closer to nitpick and touch the defects and to report any shortening, so it had to be of interest educational Supervision and development to achieve quality education ,The educational Supervision System in Egypt suffers from a lot of problems and obstacles that hinder its role in achieving quality in education, which calls for re-consideration of the objectives and principles and methods of its own, where is the link between the planners and implementers in the educational process. In the context of the ministry's keenness to develop basic education as the backbone in the educational pyramid and raise the efficiency of workers in the educational field, and under the imposed challenges ,global changes and local education had to be that there will be a future vision for the development of the educational process in general and the educational Supervision in particular,

The Problem of the Research:

The problem of the research lies in the main following question:

What is the proposed image to develop educational supervision System to establish total quality in the stage of basic education in A. R. E?

Results

The study resulted in a set of results from the most important

1. double the effective use of human and material resources available both at the district level or education departments.
2. Not a holistic educational guidance and limited educational work directed at evaluating teacher and pupil achievement and the neglect of the rest of the elements of the educational system.
3. the large number of administrative and practical burden on Educational router.
4. Lack of technical and administrative leadership eligible capable of efficient management of the educational process the desired system.
5. Double activating decentralization at the level of departments and directorates of education and twice-oriented schools, support for decentralization.

6. absence of objectivity in the educational and directed especially in the evaluation of teachers' performance and the spread of pleasantries practices.
7. lack of mentors and educators not to inform them of the all-new in the field of education and information technology training courses.
8. lack of material and moral incentives provided for mentors.
9. lack of mentors educators training courses.
10. shortage of mentors specialists and the large number of unqualified teachers educationally.
11. The lack of a clear educational goals aims to guidance.
12. poor participation of agencies involved in the ministry in determining the selection and promotion of the function-oriented standards

Recommendations and proposals

- * Holistic educational guidance and not rely only on the direct course material, but interest in the educational process in all its aspects.
- * Emphasis on attention to the rehabilitation-oriented educational and preparing pre-service and in-service continuity in the professional and self-development.
- * Attention to the quality, seminars and conferences, which help raise the efficiency-oriented and teacher training courses.
- * Emphasize that have directed a competence in his field, and has skillfully managing people and the formation of human relations with his co-workers
- * The need for interest-oriented creativity and innovation in its functions in order to be a good role model by teachers.

* Router that derives its authority and prestige of the power of his ideas and technical and professional skills of renewable and informatics constantly instead of inspection and nitpick workers and teachers ()

* To be the purpose of guidance and a way to evaluate and improve the level of teacher performance and upgrading its level ()

* That the directive on the basis of participation and cooperation between the teacher and directed, and this requires that the relationship between them on a democratic basis Salim ()

* Encourage workers to do critical thinking and experimenting construction in the performance of their business methods.

* Guidance that is focused on helping workers and teachers on professional growth and improve the performance of their professional level ()

* Administration provide the appropriate environment for practice-oriented functions and is in the following indicators:
