Thus the Rescher had thought in Using Professional intervention through with practice of family therapy approach . thus the main issus of the present study defined in Effectiveness of practicing Family therapy in facing the social problems of poliomyelitis pupils with in fantle pavalysis .

Study Recommendations :

(1) Fathers should be fully Aware of providing Appropriate milien for Raising up the children ,

Disregarding good and souned manners in Educating the children might cause many problems children suffer mack from there problems Moreover ,

the handicapped child looks upon his parents as the reason of his disability. Mean while He considers them the key solutions to his problems . such point must be taken into consideration when dealing with the Handicapped child .

(2) Causes of poliomyelitis must be promulgated families should be fully aware of preventive medical treatment ,

(3) parents Should be motified about the community and public Establishments , where they can get compensatory Equipments , fathers must promvlgated with the different domestic services , these Recommendations comply with Methods of family therapy practise (family Balance study) , This style is based upon the utmost use and benefit of all available sources inside The family and outside the family .

4 - School should beassigned a consuderable role in providing special programs , specially designed for those physically disable pupils particular attention is to be devoted to the sportive and recreational activities , suitable for the handicapped pupils .

(5) The Student would like to suggest that more studies have to be made with particular concentrating upon childhood and its problems . handicapped childhood in particular should be given special atention such studies will comply with the public policy of the government .

(6) opening an ongoing communication and good Rlationship between the poliomyelitis pupils families and the school to sort out any problems very early .

(7) The researchers should concern with the poliomyelitis studies which may Affect the process of the poliomyetlitis pupils socialization .

(8) Social workers should study the poliomyelitis pupils as individual cases and follow them up in their schools , hostels and families .

(9) poliomyelitis students should be accepted to social work faculties and institutes to graduate a polio social worker which is able to treat with the poliomyelitis pupils and his families .
