Abstract:

The question of integrating women in development is an urgent need of the society particularly in circumstances where they face the Egyptian society, with significant development challenges, you need to combine all efforts and mobilize all forces available to it, where a gender mainstreaming tool and a process of social change, make the concerns of women and men, and expectations of an essential dimension in the design of policies, programs and control in all tracks, the political, economic and social development.

The question raised by the study, how to achieve the integration of women in development more effective? To the extent that society affords them opportunities and gives their rights, legislation , institutions and support Etc.?.

Based on the above study concerned about being on the requirements of the integration of women in development through the identification of requirements for "self-knowledge and skills" needed to integrate them, identify community and that contribute to their effective participation in development, with a training program based on findings from the study of the professional practice of service social integration of women in development.

According to the objectives of the study queries belong to the study to the descriptive studies, using social survey method sample intentional clubs Women of the directorates of health, youth and social solidarity - Azab, angle, Tamyah, a youth center in the province, a youth center Atsa, Women's

Club Bobcoai (Abu-clothed) Sorority Association Community Development Battersea, sorority Balhadegp Community Development Association, and Association for the Development sorority community information in Fayoum Governorate - as was the use of social survey method of simple random sample of (139) individually, using a scale prepared to answer questions of the study.

The study found the following results:

- 1 requires the integration of women in development, a set of requirements associated with the cognitive aspects of social ,cognitive requirements associated with the economic aspects and cognitive requirements associated with the political aspects.
- 2 The importance of the availability of three basic skills of a good standard to integrate women in development is "the skill of self-investment of resources and community, communication skills and decision-making skills," while the skill to solve the problem and the skill level of change is weak.
- 3 to be the availability of community requirements necessary to integrate women in development, the level of good, important in creating enough opportunities for women.

And concluded the study to develop a proposed program of social service to provide the women attending the clubs women with the knowledge and skills needed for their integration in development, based on the assessment of women have the knowledge and skills integration in development, and then providing them with necessary to activate their roles positive in the areas of social and political development and economic reach to a good level of skills, with opportunities for community-based incentive to them.
