Abstract:

The importance of the development partnership which society is suffering from a lack of basic needs and problems hindering development, as it allows various sectors take responsibility and contribute to spread the spirit of positive competitiveness for the benefit of society, with the provision of security against blocking development projects in the future.

It aims the development partnership - provided that the community will be able to do structured in order to achieve self-development - to strengthen the rule of self-help include income-generating activities to reduce poverty and strengthening local organizations, non-governmental organizations in strengthening networks between them and the donor organizations ,other organizations.

According to the above, the development of partnership requires Building a community of ideas and practices associated with partnership as it seems that such a mechanism - a development partnership - mechanisms that concern to Egypt in their five-year, so it behooves those involved in development to support the mechanism of the development partnership, not only at the level policy formulation, implementation and management of programs and projects, but must make sure the ability of the partners themselves to assume the burden of local development.

So concerned with the study of being on the challenges facing the partnership-building effective development at the local level, through to

stand on the willingness of local partners to the possibility of working together, in the context of achieving a range of benefits ,physical and moral, identifying their views on the goals and roles that can be achieved by the partnership and related facilitating community dialogue, community investment of resources and decision-making development , the provision of community services and, finally, to identify challenges that hinder the building of partnership style relationship , the mechanism of cooperation between partners, and challenges attributed to partners themselves or the community that hinder their effectiveness.

The study was under the category of descriptive studies, the study uses the case study approach, the situation here, "village Teresa Center Sonoras" in Fayoum Governorate, expressions and their development partners in the village, and numbered (57) single rate of (64,04%) of the study, who reached the size (89) Single, using the meter as a tool for the study.

The study found the following results:

- 1 - the sample is ready to build a partnership development at the local level, and their willingness to work through the building official.
- 2 - The study sample expressed willingness to take on roles and responsibilities of the partnership at a robust level in all the roles associated with the development partners to facilitate community dialogue , the provision of developmental services , invest community resources, and decision-making community
- 3 - Check the material benefits of the development partnership at a robust level and other moral level of the average, which confirms the availability of an incentive to build partnership and to play their roles.
- 4 - The study sample expressed that the objectives of the partnership can be achieved at a robust level, but the average level of implementation mechanisms, which requires training partners to choose the appropriate mechanisms for the positions they are experiencing.
- 5 - facing the challenges associated with the development partnership relation between the partners and other local community level is strong, while the challenges associated with the differences between the partners and associated partners themselves at intermediate level.

The study concluded that how to build a partnership of development according to the perception of the proposal included the "organizational form of partnership development at the local level and the basis chosen for the roles of administrative, managerial and professional with an explanation of skills and objectives and mechanisms for implementation of the

Partnership and ways to address the challenges that emerged from the study, to take the local unit of its society's headquarters for meetings of the partners.
